RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO SUNNY GLADES PROPERTIES CORPORATION (TAGAYTAY HAVEN HOTEL) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE REGIONAL QUALITY ASSURANCE OF THE DEVELOPED ALS LEARNING RESOURCE EXEMPLARS FOR LEARNING STRANDS 1, 2 AND 3 FOR BASIC LITERACY PROGRAM, ELEMENTARY AND SECONDARY LEVELS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the REGIONAL QUALITY ASSURANCE OF THE DEVELOPED ALS LEARNING RESOURCE EXEMPLARS FOR LEARNING STRANDS 1, 2 AND 3 FOR BASIC LITERACY PROGRAM, ELEMENTARY AND SECONDARY LEVELS on APRIL 20-22, 2023;

WHEREAS, the Approved Budget for the Contract (ABC) is FOUR HUNDRED EIGHTY-SIX THOUSAND PESOS (Php486,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement Stystem (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on March 3, 2023 to March 8, 2023 at 9:00 a.m.

WHEREAS, RFQs were sent to four (4) prospective suppliers; The four (4) prospective suppliers are as follows: (1) FIRST STA. ROSA HOTEL CORP. (EL CIELITO HOTEL); (2) TAGAYTAY AUTOMART INC. – TAGAYTAY COUNTRY HOTEL; (3) THE BAYLEAF CAVITE; and (4) DEVELOPMENT ACADEMY OF THE PHILIPPINES;
