BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP)-TAGAYTAY FOR THE LEASE OF VENUE INCLUDING ACCOMMODATION AND MEALS FOR THE “ONE STOP SHOP” THEMATIC WORKSHOPS (FORWARD ESTIMATION OF BASIC INPUTS, PROGRAM PROFILING, AND FINALIZATION OF FY 2023 OPERATIONAL PLANS)

WHEREAS, on February 1, 2023, the Department of Education – Central Office issued Sub-Allotment Release Order (SARO) No. OSEC-4A-23-0287 for the provision of funds for the conduct of “One Stop Shop” Thematic Workshops (Forward Estimation of Basic Inputs, Program Profiling, and Finalization of FY 2023 Operation Plans) on February 12-17, 2023;

WHEREAS, the Bids and Awards Committee (BAC) received a letter from the end-user requesting for the Procurement of Lease of Venue with Meals and Accommodation for the said event;

WHEREAS, the Approved Budget for the Contract (ABC) is **TWO MILLION FIVE HUNDRED SIXTY-TWO THOUSAND PESOS (Php2,562,000.00)**;

WHEREAS, pursuant to the Consolidated Guidelines for the Alternative Methods of Procurement, Item V-D 9(b)(i) of Annex “H” in the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act No. 9184 states:

“i. Public-owned vis-a-vis privately-owned real property and venue.

It is preferred that government agencies lease publicly-owned real property or venue from other government agencies.

If there is an available publicly-owned real property or venue that complies with the requirements of the Procuring Entity, it may enter into a contract of lease with the government-agency owner.

In the event that the Procuring Entity would resort to privately-owned real property or venue, the End-User unit shall justify that the same is more efficient and economical to the government.”

WHEREAS, considering the urgency and the time required for this activity, the BAC with the recommendation of the end-user agreed to resort to Negotiated Procurement under the Agency-to-Agency (Sec. 53.5) as an alternative mode of procurement for the lease of venue taking into consideration the need for prudence and economy in government service, the suitability and proximity of areas;

WHEREAS, after review and deliberation on the proposal, the **DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP)-TAGAYTAY** is found to comply with the requirements;


