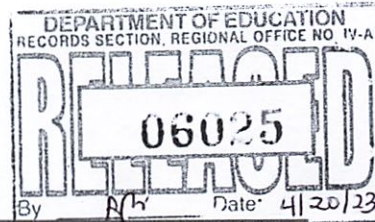

REGIONAL CONFERENCE ON SCHOOL SITES REGISTRATION AND TITLING

To: **Schools Division Superintendents**

1. Item E, No. 7 of Republic Act 9155 provides that the school head shall administer and manage all personnel, physical and fiscal resources of the school.
2. At present, public schools are confronted with legal issues and other pressing concerns involving schools sites such as, but not limited to, complaints for recovery of possession and ownership, demand to vacate the school site and other claims for payment of rental fee. Workload pertaining to these matters result to distractions from curriculum implementation and instructional leadership.
3. In view of this, the Office of the Regional Director through the Legal Unit will conduct the REGIONAL CONFERENCE ON SCHOOL SITES REGISTRATION AND TITLING on May 9, 2023, at the National Educators Academy of the Philippines (NEAP), Malvar, Batangas, from 8:30 in the morning to 5:00 in the afternoon.
4. This Conference intends to strengthen the capability of the participants in the legal and practical aspects on issues involving lands occupied by public schools by providing them an in-depth knowledge on the different procedures in school site acquisition, registration and titling.
