

This has reference to the application for Department of Education (DepEd) Financial Assistance to Private Madaris for School Year 2022-2023.

Please be informed that based on the review and evaluation made by the Bureau of Learning Delivery - Student Inclusion Division (BLD-SID), the following schools have qualified for financial assistance from DepEd:

1. Amanah Integrated School, Inc.; and

2. Islamic Studies Call & Guidance of the Philippines, Inc.

Pursuant to DepEd Order (DO) No. 49, s. 2021 entitled Revised Guidelines on the Grant of Financial Assistance to Private Madaris Adopting K to 12 Basic Education Curriculum, the aforesaid schools in your region shall receive the amount of Php 5,000.00 per learner. The total amount to be received by each school is indicated below:

Name of School	No. of Learners	Amount to be received
Dar Amanah Children's Village Foundation Inc.	5	Php 25,000.00
Islamic Studies Call & Guidance of the Philippines, Inc	17	Php 85,000.00

Further, it is emphasized that the financial assistance be strictly utilized only for the operation and enhancement of instruction in the said schools. Specifically, eighty percent (80%) of the financial assistance is intended for the salary of the K to 12 teachers and twenty percent (20%) shall be allotted for the improvement of the school facilities, printing and delivery of Self Learning Modules (SLMs), and teachers' registration and transportation to DepEd-sponsored teacher trainings within the nearby division/region, subject to the usual government accounting and auditing rules and regulations.
