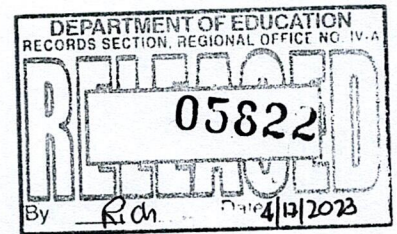

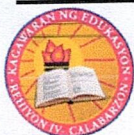

1. This Office, through the Human Resource Development Division (HRDD), in collaboration with the Regional **Program on Awards and Incentives for Service Excellence (PRAISE)** Committee, announces the Stage 2 qualifiers for the SDO Category. Please see the attached enclosure.
2. The Best Performing Schools Division Office Stage 2 qualifiers will undergo on-site validation on May 2-3, 2023, and are expected to prepare their MOVs for validation.
3. The Regional PRAISE Committee reiterates that it strictly follows the provisions stated in the guidelines. Nominees who **failed to submit** the required nomination documents as stated in the checklist were **disqualified** from participating in the search. Likewise, those who failed to reach the cut off score of 70 percent were not able to advance to the next stage of the search.

5. Expenses of the regional validators relative to the onsite validation such as travel expenses, board and lodging and other miscellaneous expenses shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
