WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **SECURITY SERVICES FOR THE YEAR 2023 FOR NATIONAL EDUCATOR'S ACADEMY OF THE PHILIPPINES (NEAP) AT MALVAR, BATANGAS** on **JUNE 1, 2023 TO MAY 31, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **EIGHT HUNDRED FIVE THOUSAND TWO HUNDRED PESOS (Php805,200.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System, office website and conspicuous bulletin board in the premises of this Office starting on March 30, 2023 to April 4, 2023 at 9:00 a.m.

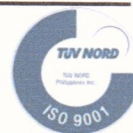




