In compliance with the provisions of Philippine Republic Act No. 11934, also known as the "SIM Card Law," which requires the registration of SIM cards before activation, the Disaster Risk Reduction and Management Service (DRRMS) hereby requests all DRRM Information System (DRRMIS) users to register their SIM cards.

It is imperative that all existing SIM card subscribers comply with the law by registering their SIM cards within one hundred eighty (180) days from the act's effectivity to avoid automatic deactivation. The official registration period concluded on April 26, 2023, and the Department of Information and Communications Technology may extend it for a maximum of one hundred twenty (120) days.

Therefore, we urge you to take immediate action to ensure that your SIM cards are registered before the deadline on July 25, 2023. Failure to register may result in SIM card deactivation, causing delays in reporting on the RADaR application and hindering its smooth operation.
