**CORRIGENDUM TO THE REGIONAL MEMORANDUM NO.
187, S. 2023 TITLED: EVALUATION OF THE 8TH
CYCLE BERF RESEARCH PROPOSALS**

Functional Division Chiefs

1. With reference to Regional Memorandum No. 187, s. 2023 on the Evaluation of the 8th Cycle Basic education Research Fund (BERF) Research Proposals, this Office, through the Policy, Planning and Research Division (PPRD), disseminates the following clarificatory provisions, to wit:
 - a. Paragraph 1 of the RM No. 187, s. 2023 which states that the activity will be in blended modality is hereby rescinded. Thus, it will be a virtual activity via MS Teams. To receive the meeting link, the participants are advised to register on or before May 12, 2023.
 - b. Paragraph 3 of the aforementioned issuance which states the expected participants in the activity is hereby revised. Thus, the additional participants shall include the Senior Education Program Specialists (SEPSs) for Planning and Research to expedite the evaluation of the research proposals. The assigned schools division offices to be evaluated by each SEPS shall be not be within his/her jurisdiction to avoid biases in the evaluation process.
