

**SCREENING AND ACCREDITATION OF ATHLETES FOR
DEPED REGION IV-A (CALABARZON) BY THE NATIONAL
SCREENING AND ACCREDITATION COMMITTEE (NSAC)**

To **Schools Division Superintendent**

1. Section 2 of Enclosure 2 of DepEd Memorandum 5 s. 2023 provides that the National Screening and Accreditation Committee shall evaluate and verify the authenticity of the documents of athletes, coaches, assistant coaches, and chaperones, submitted by the Head of Delegation for the Palarong Pambansa and accredit qualified athletes, coaches, assistant coaches, and chaperones.
2. On the other hand, Section 11 of the Enclosure 2 of the same memorandum provides that the Head of the Delegation shall submit to the NSAC within fifteen (15) days after their regional meet the master list and picture galleries (soft and hard copies) of their athletes coaches, assistant coaches, and chaperones.
3. For the delegation to comply on time with the directives, all members of the Regional Screening and Accreditation Committee (RSAC) identified in the Enclosure No. 1 to Regional Memorandum No. 106, s. 2023 dated February 21, 2023, are hereby ordered to appear on **May 6, 2023 at 8:00 in the morning to 5:00 in the afternoon at Tagaytay National High School, Tagaytay City** to assist the National Screening and Accreditation Committee (NSAC) in performing their functions as stated above and to do such other acts.
4. Similarly, all candidate athletes for the 2023 *Palarong Pambansa* who are identified in the Regional Memorandum No. 221, s. 2023 dated April 24, 2023, are hereby directed to return on **May 6, 2023**, to Tagaytay National High School, Tagaytay City, for an interview with the NSAC.
5. The interview will be conducted in two (2) batches. Candidate athletes from the Schools Division Office of Quezon, Lucena City, San Pablo City, Tayabas City, Sto. Tomas City, Rizal, Antipolo City, Calamba City, Laguna, San Pedro City, Tanauan City, and Lipa City are directed to appear before the NSAC in the morning from 8:30 to 12:00, while candidate athletes from Cavite Province, Cavite City, Bacoor City, General Trias City, Dasmariñas City, Imus
