**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO LORELAND FARM RESORT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE SKILLS ENHANCEMENT TRAINING ON DIGITAL MATERIAL PRODUCTION FOR REGIONAL OFFICE PROPER (ROP)**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **SKILLS ENHANCEMENT TRAINING ON DIGITAL MATERIAL PRODUCTION FOR REGIONAL OFFICE PROPER (ROP)** on **MAY 23-26, 2023**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **THREE HUNDRED TWELVE THOUSAND PESOS (Php312,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on April 28, 2023 to May 5, 2023 at 9:00 a.m.

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) First Villa Cristina Hotel & Resort, Inc.; (2) First Philippine Realty Corporation (Eugenio Lopez Center); and (3) Focal Managing Loop Inc.;

**WHEREAS**, one (1) Supplier submitted its proposal; **LORELAND FARM RESORT** in the amount of **THREE HUNDRED TWELVE THOUSAND PESOS (Php312,000.00)**. Thus, **LORELAND FARM RESORT** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **LORELAND FARM RESORT** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **LORELAND FARM RESORT** in the amount **THREE HUNDRED TWELVE THOUSAND PESOS (Php312,000.00)**.


