RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO TAGAYTAY COUNTRY HOTEL FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE WORKSHOP ON FINALIZATION OF REGIONAL CONTEXTUALIZED ASSESSMENT TOOL FOR KS1 THROUGH LAMP

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION FOR THE WORKSHOP ON FINALIZATION OF REGIONAL CONTEXTUALIZED ASSESSMENT TOOL FOR KS1 THROUGH LAMP** on **MAY 26-28, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED SIXTY THOUSAND PESOS (Php360,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office on May 4, 2023 to May 8, 2023 at 9:00 a.m.;

WHEREAS, on May 4, 2023, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) Tagaytay Country Hotel; (2) Bayleaf Hotel Cavite; and (3) WhiteWoods Convention and Leisure Hotel;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:


