## **BAC RESOLUTION**

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE PROGRAM ON WELFARE FOR EMPLOYEES OF REGIONAL OFFICE (POWER-O) – EMPLOYEES ENGAGEMENT ON PHYSICAL WELLNESS ACTIVITIES

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the PROGRAM ON WELFARE FOR EMPLOYEES OF REGIONAL OFFICE (POWER-O) – EMPLOYEES ENGAGEMENT ON PHYSICAL WELLNESS ACTIVITIES on MAY 22, 2023 and OCTOBER 27, 2023;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED THIRTY-THREE THOUSAND FIVE HUNDRED PESOS (Php133,500.00)**;

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on May 11, 2023 to May 16, 2023 at 9:00 a.m.

**WHEREAS,** RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) GOD'S TREASURE ENTERPRISES; (2) MEYER'S FOODS AND SERVICES, INC.; and (3) FOCAL MANAGING LOOP INC.;

WHEREAS, one (1) Supplier submitted its proposal; GOD'S TREASURE ENTERPRISES in the amount of ONE HUNDRED THIRTY-THREE THOUSAND TWO HUNDRED TWENTY PESOS (Php133,220.00). Thus, GOD'S TREASURE ENTERPRISES is declared as the lone bidder;

**WHEREAS,** after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD'S TREASURE ENTERPRISES** in the amount **ONE HUNDRED THIRTY-THREE THOUSAND TWO HUNDRED TWENTY PESOS** (**Php133,220.00**).
