**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **CONDUCT OF FELLOWSHIP OF LEADERS IN AN EXPERIENTIAL ENGAGEMENT FOR A RESILIENT TEAM (FLExpERT)** on **JUNE 8-9, 2023** and **JUNE 13-15, 2023**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **SIX HUNDRED THOUSAND PESOS (Php600,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on May 26, 2023 to May 31, 2023 at 9:00 a.m.

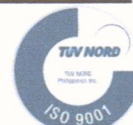
