**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF
CONTRACT TO D'LUXE WATER REFILLING STATION FOR THE
PROCUREMENT OF PURIFIED WATER WITH 3 PIECES OF WATER DISPENSER
UNIT FOR THE REGIONAL OFFICE EMPLOYEES**

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **PURIFIED WATER WITH 3 PIECES OF WATER DISPENSER UNIT FOR THE REGIONAL OFFICE EMPLOYEES**;

WHEREAS, the Approved Budget for the Contract (ABC) is **SIXTY-ONE THOUSAND THREE HUNDRED TWENTY PESOS (Php61,320.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPs), office website and conspicuous bulletin board in the premises of this Office starting on March 26, 2023 to June 2, 2023 at 9:00 a.m.

WHEREAS, RFQs were sent to three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) D'LUXE WATER REFILLING STATION; (2) EMMINA'S ALKALINE & MINERAL WATER REFILLING STATION; and (3) WEST HOPE SPRINGS WATER SUPPLY;

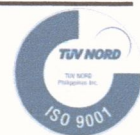
WHEREAS, one (1) Supplier submitted its proposal; **D'LUXE WATER REFILLING STATION** in the amount of **SIXTY-ONE THOUSAND THREE HUNDRED TWENTY PESOS (Php61,320.00)**. Thus, **D'LUXE WATER REFILLING STATION** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **D'LUXE WATER REFILLING STATION** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **D'LUXE WATER REFILLING STATION** in the amount **SIXTY-ONE THOUSAND THREE HUNDRED TWENTY PESOS (Php61,320.00)**.
