**CONDUCT OF CONSULTATION CONFERENCE WITH

1. In reference to OUPS No. 07- 1656, s. 2023 ¹, this office through the Education Support Services Division, will conduct a Consultation Conference with Learners, Teachers, Parents, and Community on the Enhancement of the Child Protection Policy. The schedule of the activity is attached herewith.
2. The consultation conference aims to gather information and feedback on the draft Child Protection Policy.
3. The list of participants to this will be selected by the Schools Division Office and entitled to service credit as per DepEd Order No.53, s. 2033 while the non-teaching and teaching related personnel are entitled to compensatory time-off as stated in CSC and DBM Join Circular No. 2. S. 2004. The Regional Learner Rights and Protection (LRP) focal will conduct random monitoring of the activity.
4. The LRP focal person shall adhere with the set standards and protocols in the conduct of the consultation conferences and shall ensure the safety of the participants during the activity.
5. The expenses such as meals, materials, transportation of the facilitators and other incidental expenses shall be charged against SUB – ARO downloaded by the Central Office while the transportation expenses of the learners and adult participants shall be charged against local funds both subject to usual accounting and auditing rules and regulations.
