

## ANGKOP AT SAPAT NA IMPRASTRAKTURANG PANG-EDUKASYON PARA SA BANSANG MAKABATA, BATANG MAKABANSA

### **Background**

Since the United Nations Conference on Environment in Rio de Janeiro in 1992, countries have put more emphasis on the role of education in achieving sustainable development. Thus, making it a constant and integral part of the sustainable development agenda i.e., Millennium Development Goals, Muscat Agreement, United Nations (UN) Conference on Sustainable Development (Rio+20), etc. Correspondingly, the UN highlighted anew that countries need to "ensure inclusive and equitable quality education and promote lifelong learning opportunities for all," in Sustainable Development Goal (SDG) 4, 2030 Agenda for Sustainable Development.

In the case of the Philippines, the State consistently promoted quality and free education by putting the highest budgetary priority to education, as enshrined in the 1987 Constitution. Republic Act No. 10533 or the Enhanced Basic Education Act of 2013 was also enacted, among others, to improve the competency of Filipino learners by adopting a curriculum that is learner-centered and culture-sensitive.

Relatedly, a study conducted by the Philippine Institute of Development Studies (PIDS) (2021) showed that the national education budget tripled from 2010 to 2020. Said increase was attributed to the implementation of the K to 12 Basic Education Program which requires the hiring of more teachers and building more classrooms for additional grade levels.

Even so, the Southeast Asia Primary Learning Metrics showed that the Philippines ranked in the lowest half among the participating countries, in terms of reading, mathematics, and literacy. Further, the World Bank (2022) argued that the learning poverty rate in the Philippines is 90.9% connoting that nine out of ten 10-year-old Filipino children are not capable to read and understand a simple text. In relation to this, literature shows that learning outcome is linked to school infrastructure and resources. Murillo and Roman (in PIDS, 2022) shows that the adequate provision of basic services and facilities e.g., potable water, proper sewage, sport installations, laboratories, etc. has a positive impact in the achievement of primary education students in various standard tests. Elland (2017) also argued that electrification of schools, particularly those in rural areas, can affect school performance by facilitating the functioning of other education infrastructure.

In January 2023, no less than the Vice President and Education Secretary Sara Duterte, in her presentation of the Basic Education Report 2023, echoed the results of the abovementioned studies on the low academic proficiency of Filipino learners. She also highlighted that the "most pressing issue" in the education sector is the lack of school infrastructure and facilities. It was noted that only 104,536 out of the 327,851 school buildings are in good condition. There are also 100,072 schools requiring minor repairs, 89,252 that need major repairs, and 21,727 that are set for condemnation.

Over the years, significant progress has been noted in the classroom-student ratios in various regions. DepEd's FY 2019 National School Building Inventory shows that the

country still requires 110,954 classrooms to achieve the ideal 1:40 classroom-student ratio. However, the target of 1:40 classroom-student ratio is yet to be achieved in CALABARZON particularly in junior high school level due to high population density. This may be exacerbated as the region also has the highest number of school buildings for demolition or replacement. Out of the 28,508 buildings for replacement in the country, 3,702 are in the region which connotes the need for 11,106 equivalent number of classrooms (PIDS, 2022).

Thus, aligned with SDG 4 and the Philippine Development Plan 2023 to 2028, of substantially improving the learning poverty in the country, the Department of Education launched *MATATAG*: *Bansang Makabata, Batang Makabansa* to set the agency and stakeholders' new agenda in addressing basic education concerns and challenges. *MATATAG* is composed of four (4) critical components:

- MAke the curriculum relevant to produce component and jobready, active, and responsible citizens;
- TAke steps to accelerate delivery of basic education facilities and services;
- TAke good care of learners by promoting learner well-being, inclusive education, and a positive learning environment; and
- Give support to teachers to teach better.

The aforementioned data and agenda give rise to questions such as: What specific strategies and policies will address infrastructure gaps in the education sector? What hinders the country from achieving low learning poverty rate? How can the private sector assist the government in improving public education infrastructure? Why are there delays in the implementation of infrastructure projects?

With these questions in mind, the Regional Dagyaw 2023 Open Government Town Halls will discuss how the government could reassess and recalibrate their approach to addressing the education challenges that our country is currently facing particularly on redundant projects, establishment of facilities and infrastructures, and procurement of equipment. Speakers will be invited from the Government, Academe, and Nongovernmental organization to discuss issues and share their insights on the matter.

### **Objectives**

- Inform citizens of the government's plans on the current agenda and status of the country and region's educational sector;
- Hold an in-depth discussion with representatives from key sectors on the efficient and effective implementation and procurement of public education infrastructures, facilities and equipment; and
- 3. Explore ways and mechanisms where various sectors of society can participate in achieving inclusive and equitable quality education in the country vis-à-vis the region.

## Town Hall Report (45 minutes)

The following critical questions should lead the presentation report:

- What is the current status of the public education sector in the region?
- How does the government assess the learning capabilities of the students?
- How does the availability of public education facilities, infrastructures and equipment affect teaching and learning conditions in the region?
- What are the specific PPAs established under the MATATAG Agenda that will improve public education facilities, infrastructures and equipment?
- How can the various sectors of society contribute in the achievement in accelerating delivery of basic education facilities and services?

The presentation should be delivered in **fifteen (15) minutes**. If it is possible, use the **PowerPoint template** given by the organizers.

Following the lecture, the **moderator** will facilitate a **dialogue**. The **panel discussants** will have to address questions from the moderator and the audience.

### **Group Discussion (80 minutes)**

To ensure the quality of participation and to facilitate a genuine open sharing of insights and possibilities, a **group discussion with the representatives from the Government, Academe, and Non-Government Organizations (NGOs)** will be held.

A series of essential questions will be brought up for at least four (4) rounds, followed by an open discussion in which everyone will have the opportunity to respond and/or offer questions, comments or clarifications.

The following core questions will lead the open discussion for each round:

- What aspects of the current policies and programs implemented do we need to maintain or modify?
- What factors hinder the country from achieving an optimal level of public education infrastructure?
- How does the private sector ensure that adequate facilities and equipment are provided to its learners? What best practices may be adopted by the public education sector?
- How are Civil Society Organizations (CSOs) involved in the implementation of public education programs, activities and projects (PAPs)? What are the strategies adopted to encourage active participation among CSOs?

Questions gathered via registration may be presented.

It should be noted that each resource person will be given a maximum of three (3) minutes to respond to each important questions, followed by an eleven (11) minute open discussion.
