

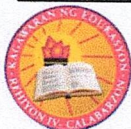
**COORDINATION MEETING IN PREPARATION FOR 2023
