BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO RALCO COMMERCIAL TRADING FOR THE PROCUREMENT OF DELEGATION UNIFORMS OF REGION IV-A CALABARZON TO THE 2023 PALARONG PAMBANSA

WHEREAS, on May 26, 2023, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the **DELEGATION UNIFORMS OF REGION IV-A CALABARZON TO THE 2023 PALARONG PAMBANSA** in the PhilGEPS website, office website, and in conspicuous bulletin board of the Office;

WHEREAS, the Approved Budget for the Contract (ABC) is **FOUR MILLION TWO HUNDRED SEVENTY-FOUR THOUSAND TWO HUNDRED PESOS (Php4,274,200.00)**;

WHEREAS, one (1) bidder submitted its sealed bid at the Regional Office;

WHEREAS, using the checklist of required documents and taking into account the non-discretionary "Pass or Fail Criterion", the BAC found that the lone bidder, **RALCO COMMERCIAL TRADING**, was eligible for being compliant with the required documents. Thus, **RALCO COMMERCIAL TRADING** was rated as "Passed".

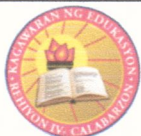
WHEREAS, per Abstract of Bids, **RALCO COMMERCIAL TRADING** has the Single Calculated Bid (SCB) with a total amount of **THREE MILLION NINE HUNDRED SEVENTY-FIVE THOUSAND SIX PESOS (Php3,975,006.00)**;

WHEREAS, upon Post-Qualification and careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted by **RALCO COMMERCIAL TRADING**, being the Single Calculated Bidder has been found to be responsive;

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED**:

1. **To DECLARE RALCO COMMERCIAL TRADING** as the Single Calculated and Responsive Bidder in the amount of **THREE MILLION NINE HUNDRED SEVENTY-FIVE THOUSAND SIX PESOS (Php3,975,006.00)**; and
2. **To RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the **award of contract to RALCO COMMERCIAL TRADING** for the Delegation Uniforms of Region IV-A CALABARZON to the 2023 Palarong Pambansa.


