RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO LOUIE AND CHIT RESTAURANT AND EVENT CENTER FOR THE PROCUREMENT OF CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS FOR THE WORKSHOP ON THE ESTABLISHMENT OF SDD BASING SYSTEM

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS** for the **WORKSHOP ON THE ESTABLISHMENT OF SDD BASING SYSTEM** on **MAY 24-26, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **SEVENTY-THREE THOUSAND FIVE HUNDRED PESOS (Php73,500.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on May 4, 2023 to May 8, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) Louie and Chit Restaurant and Event Center; (2) Meyer's Foods and Services, Inc.; and (3) Jun & Cristy Catering Services;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:






