Pursuant to DepEd Order 41, s. 2017 Policy Guidelines on Madrasah Education in the K to 12 Basic Education Program and DepEd Order 25, s. 2021 Revised Implementing Guidelines on the Utilization of Fund for Madrasah Education Program, this Office, through the Curriculum and Learning Management Division (CLMD), announces the conduct of BLD-SID ONSITE MONITORING OF IMPLEMENTING SCHOOLS IN MADRASAH EDUCATION PROGRAM (MEP) IN CALABARZON on August 2-4, 2023 at SDO Dasmariñas City and SDO Lipa City.

 - a) ensure that policy guidelines of MEP are fully implemented
