NATIONAL TRAINING OF EDUCATION PROGRAM SPECIALISTS II FOR ALS (EPSA) ON THE PROVISION OF TECHNICAL ASSISTANCE ON THE IMPLEMENTATION OF CONTEXTUALIZED MELCS-BASED SHS CURRICULUM FOR ALTERNATIVE LEARNING SYSTEM

To: Schools Division Superintendents

- 1. In reference to DepEd Memorandum No. 122, s. 2023, re: National Training of Education Program Specialists II for ALS (EPSA) on the provision of Technical Assistance on the Implementation of Contextualized MELCS-Based SHS Curriculum for Alternative Learning System, the Bureau of Alternative Education (BAE) in coordination with the Bureau of Curriculum (BCD) and in partnership with the Asian Development Bank, will conduct the activity on July 24-28, 2023, at Teachers Camp, Baguio City.
- 2. The activity aims to:
 - a. develop among EPSAs a deep understanding, familiarization, and appreciation of the contextualized MELCs-based ALS SHS Curriculum;

 - c. enable the EPSAs to enhance the developed lesson plans through unpacking and contextualization of competencies, and feedbacking to demonstration teaching and simulations.
