**REGIONAL ORIENTATION OF ALS TEACHERS ON THE  
IMPLEMENTATION OF THE CONTEXTUALIZED  
MELCS BASED ALS SHS CURRICULUM**

To **Schools Division Superintendents**

1. In reference to DepEd Memo 048, s. 2022 re: National Orientation of ALS Teachers on the Implementation of the Contextualized MELCs-Based ALS Senior High School Curriculum, the Curriculum and Learning Management Division (CLMD) will conduct the Regional Orientation of ALS Teachers on the Implementation of the Contextualized MELCs-Based ALS SHS Curriculum on **August 14-18, 2023**. 3. Participants in this activity are Regional Technical Working Group (RTWG), SDO ALS Focal Persons, Education Program Specialists for ALS (EPSA), Teachers teaching in ALS SHS. Teacher participants are required to bring laptop, extension cord and ALS Curriculum guide.
4. Traveling and other incidental expenses of the participants shall be charged to Local Fund (ALS PSF) subject to the usual government accounting and auditing rules and regulations.
