WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **WORKSHOP ON THE QUALITY ASSURANCE OF REGIONAL STORYBOOK WINNERS AND SDO CONTEXTUALIZED AND DEVELOPED DIGITIZED LR_s FOR KINDERGARTEN** on **AUGUST 1-3, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **FIVE HUNDRED TWELVE THOUSAND PESOS (Php512,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on July 13, 2023 to July 17, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) First Sta. Rosa Hotel Corporation (El Cielito Hotel – Sta. Rosa); (2) Techno Park Hotel; and (3) Leonida's Exclusive Resort;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:


