

The Pantawid Pamilyang Pilipino Program is currently in its 3<sup>rd</sup> compliance monitoring period (June-July 2023 monitoring months). Unfortunately, some Social Welfare Assistants of 4Ps from the different Provinces of Region IV-A raised their concerns regarding the refusal of several teachers to accomplished the CV Forms while on their vacation. This issue/concern will greatly affect the beneficiaries and the implementation of the program since the CVS Forms serve as the basis for the cash grants that the beneficiaries will receive.

Moreover, due to the enhancement of the CV Forms 2 and ongoing migration of data from Pantawid Pamilya Information System (PPIS) version 2 to PPIS version 3, the timeline for June-July 2023 monitoring was adjusted. However, despite the limited time, we ensure the on-time provision of cash grants to eligible Pantawid beneficiaries.
