To: Schools Division Superintendents

1. In reference to OM-OASOPS-2023-07-023, s. 2023¹, this Office, through the Education Support Services Division announces the screening of the Biopic “Oscar M. Alcaraz, Ang Boy Scout na Bayani” directed by Antonio San Agustin, KDPP.
2. The film aims to mold the invaluable Filipino values in eager young minds by emulating Oscar M. Alcaraz as a Boy Scout role model and as someone who became the first civilian to be given the honor of being laid to rest at the Libingan ng mga Bayani. As per review by the Public Affairs Services (PAS), the film is aligned with the core values of the DepEd and sees no negative portrayal of learners, teachers, and other education stakeholders.

The participation of public and private schools shall be subject to the no-disruption-of-classes policy stipulated in DepEd Order No. 9, s. 2005 titled, “Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith,” and the policy on off-campus activities stated in DepEd Order No. 66, s. 2017. This is also subject to the no-collection policy as stated in Section 3 of Republic Act No. 5546 also known as “An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities(Ganzon Law).”



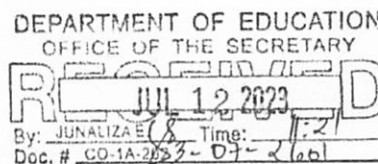

DepEd eyes mandatory scouting in basic education curriculum

"This is something that we have been discussing within the Office of the Secretary of the Department of Education (DepEd) - on how to integrate mandatory scouting into the Filipino Basic Education Curriculum," Vice President and Education Secretary Sara Duterte said.

MANILA, Philippines — After initially supporting the mandatory Reserve Officers' Training Corps (ROTC) program in the senior high school program, Vice President and Education Secretary Sara Duterte is now looking at integrating mandatory scouting in the basic education curriculum.

During a speech at the annual national council meeting of the Boy Scouts of the Philippines (BSP) in Palo, Leyte on Thursday, Duterte noted how the scout movement has proven itself as an integral part of the education system.

"This is something that we have been discussing within the Office of the Secretary of the Department of Education (DepEd) — on how to integrate mandatory scouting into the Filipino Peace Culture curriculum," she said.

She noted that the values that young Filipino boys learn from the Scout movement, including honesty, integrity, respect and service to others, are necessary in achieving the goals of government.

"The Marcos administration aggressively implements programs and projects that are aimed at fortifying our strength, our security and our stability as a nation," she said.

"Along with this is our vision of giving rise to a generation of Filipinos with an enduring love of country — a generation with the willingness and capability to help the government ensure that the Philippines becomes strong, secure and stable," she added.

In 2012, then DepEd Secretary Armin Luistro issued an order to revitalize boy scouting in public schools, saying that it has been an effective co-curricular program in the leadership and values formation of the child.

But it maintained that membership to the BSP is voluntary and shall not be made a condition for enrollment, transfer or clearance of students.

Duterte earlier supported the implementation of the mandatory ROTC program in senior high school.

But following a meeting with lawmakers in September, she said "it was clear to everyone that it is better to return ROTC in higher education since it was already there before."

"The basic education will focus on other parts of the curriculum that would instill discipline and love of country for our learners," she added.

In her speech, Duterte also urged the BSP to support their programs for the Filipino youth.

"Help us protect our children from sexual abuses, slavery, the lure of illegal drugs and the deception of the terrorist Communist Party of the Philippines and its armed terrorist group, New People's Army, as well as recruitment into extreme religious violent extremism," she said.

OSCAR M. ALCARAZ: ANG BOY SCOUT NA TUNAY NA BAYANI

The ETR Films presents the biographical film, Oscar M. Alcaraz: Ang Boy Scout Na Tunay Na Bayani, featuring the first civilian to be given the honor of being laid to rest at the Libingan ng mga Bayani (Heroes' Cemetery), in Fort Bonifacio.

Scout Alcaraz, then a student of the Eulogio Rodriguez Jr. High School in La Loma, Quezon City, was born on May 4, 1953. He died a heroic death when he unselfishly saved the life of his drowning Scoutmaster during a reforestation project at the La Mesa Dam in Novaliches, Quezon City.

Led by multi-awarded child performer Robert "Buboy" Tamayo Villar Jr., the film showcases the gallantry and heroism of Scout Oscar, and how he deserved the Presidential Merit and Medal conferred by then President Ferdinand E. Marcos on September 11, 1970, at the Malacanan Palace.

Directed by Antonio San Agustin, kdpp, the movie commenced in March 2023, both internationally and locally.
