- WELLness** – Physical health, mental health, disaster preparedness, first aid, etc.
 - “Legal Matters”** – Legal Officers discuss legal issues / bases and answer frequently asked questions (FAQs)
 - TAL’ento (Talent na may Kwento)** – Weekly intermission number either musical, dance, arts, etc. featuring students, teachers, non-teaching personnel, parents per episode.
