CONDUCT OF THE 2023 REGIONAL OPLAN BALIK ESKWELA (OBE) LAUNCH AND PRESS CONFERENCE

To Schools Division Superintendents

- DepEd CALABARZON will launch the Oplan Balik Eskwela (OBE) to engage agencies, organizations, and other stakeholders in preparation for the opening of the school year. Likewise, it will organize the OBE-Public Assistance Action Center (OBE-PAAC) which is responsible for handling text hotlines, email, and social media inquiries in preparation for the opening of classes for SY 2023- 2024.
- In line with this, the Regional Office, through the Public Affairs Unit (PAU) will conduct the 2023 OBE Launch and Press Conference on August 23, 2023 at 9:00 a.m at Bulwagan ng Karangalan, DepEd CALABARZON Regional Office, Gate 2, Karangalan Village, Cainta, Rizal Province.
