#### To Schools Division Superintendents

- This Office through the Quality Assurance Division (QAD) announces the conduct of the Capacity Building Cum Workshop with SDO Counterparts on the Processes for the Establishment of Public and Private Schools to be held on September 14-15, 2023 at the venue to be announced in a separate advisory.
