RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE TRAINING ON REPUBLIC ACT NO. 9184 ALSO KNOWN AS THE GOVERNMENT PROCUREMENT REFORM ACT (GPRA) AND ITS 2016 REVISED IMPLEMENTING RULES AND REGULATIONS (R-IRR)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the TRAINING ON REPUBLIC ACT NO. 9184 ALSO KNOWN AS THE GOVERNMENT PROCUREMENT REFORM ACT (GPRA) AND ITS 2016 REVISED IMPLEMENTING RULES AND REGULATIONS (R-IRR) on AUGUST 23-25, 2023;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED EIGHTY THOUSAND PESOS (Php180,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting starting on August 7, 2023 to August 11, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) SUNRISE RIDGE CORPORATION (SOLESTE SUITES); (2) RED HOTEL; and (3) B HOTEL;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
