CANCELLATION OF PUBLIC BIDDING FOR THE PROCUREMENT OF SUPPLY AND DOOR TO DOOR DELIVERY OF SCHOOL FURNITURE FOR ELEMENTARY, JUNIOR AND SENIOR HIGH SCHOOLS UNDER THE BASIC EDUCATIONAL FACILITIES FUND (BEFF) SCHOOL FURNITURE PROGRAM CY 2022 (ROIVA-23-03)

WHEREAS, on September 2, 2023, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the **PROCUREMENT OF SUPPLY AND DOOR TO DOOR DELIVERY OF SCHOOL FURNITURE FOR ELEMENTARY, JUNIOR AND SENIOR HIGH SCHOOLS UNDER THE BASIC EDUCATIONAL FACILITIES FUND (BEFF) SCHOOL FURNITURE PROGRAM CY 2022 (ROIVA-23-03)** in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website, and in conspicuous bulletin board of the office;

WHEREAS, on September 12, 2023 at 9:00am at Bulwagan ng Karangalan, DepEd Region IV-A, Gate 2 Karangalan Drive, Cainta, Rizal, a pre-bid conference was conducted and attended by thirteen (13) prospective suppliers;

WHEREAS, on September 13, 2023, the Procuring Entity sent a letter to Ms. Emelita P. Bagsit, Regional Director, Department of Science and Technology requesting a recommendation on the level of performance/durability required to ensure that the school furniture is in best quality and workmanship.

WHEREAS, on September 14, 2023, the BAC conducted a meeting relative to some issues and concerns that need clarification from DepEd - Central Office, Department of Science and Technology-Forest Product Research and Development Institute (DOST-FPRDI) and some revisions in the Bid Documents, as follows:

1. The End-user is still waiting for the response of DepEd -Central Office regarding the specific thickness of High-Density Polyethylene (HDPE) for the learner's chair and the required level of performance/durability for the testing of furniture;
2. The Procuring Entity requested from DOST-FPRDI the recommended level of performance/durability that ensures the school furniture is of best quality and workmanship; and
3. There are some provisions in the Bid Documents that need to be modified/revised.


