Department Order 001, s. 2023, creating the School Infrastructure and Facilities (SIF) Strand tasked to mobilize Civil Society Organizations (CSOs) to assist in the acceleration of the School Building Program (SBP) through the creation of the School Building Monitoring Program under the School Infrastructure Management Office (SIMO). The same is reflected in the General Appropriations Act of 2023 that provides for the capacity building of CSOs to provide checks and balances for the implementation of the SBP.

- 3. Conduct monitoring activities based on the submitted activity plans; and
- 4. Submit the results of the monitoring.
