**2023 MICROSOFT YOUTH AMBASSADORS (MYA)
CAPSTONE PROJECT IMPLEMENTATION**

To **Schools Division Superintendents**

1. In reference to OM-OASOPS-2023-0¹, this Office, through the Education Support Services Division, disseminates the conduct of a series of 2023 Microsoft Youth Ambassadors (MYA) Capstone Projects from September 18 to November 10, 2023, which will be done on a hybrid setting and will be led by the successful MYA 2.0 participants nationwide.
2. The activity aims to:
 - a. onboard empowered Filipino learners who will represent the Department of Education (DepEd) by promoting the innovative and responsible use of technology in the school and the community;
 - b. provide learners with access to resources and a variety of opportunities to deepen their knowledge and practice their skills while supporting their curricular and co-curricular activities; and
 - c. promote the importance of creating and maintaining a culture of digital citizenship that extends beyond the classroom and the school.
3. The participants in this activity are learners from junior and senior high school and on a voluntary basis. The activities shall be allowed, provided that they are conducted after class hours when classes are not hampered or disrupted. Time on task policy must be observed. Attached is the list of Region IV-A CALABARZON MYA 2.0 Implementers to facilitate and lead the sessions.
4. The Participation of public and private schools shall be subject to the no disruption-of-classes policy stipulated in DepEd Order No. 9, s. 2005 titled, "Instituting Measures to Increase Engaged Time-on-Task and Ensuring


