

SUBJECT : **INSTRUCTION TO EXPEDITE THE ENCODING OF ENROLLMENT
DATA IN THE QUICK COUNT FACILITY IN THE LIS FOR SCHOOL
YEAR 2023-2024**

This memorandum reiterates the importance of encoding enrollment data in the Quick Count Facility in the Learner Information System (LIS), particularly in monitoring enrollment updates in our schools for reporting to the different offices across all governance levels and stakeholders.

The Quick Count Facility for School Year 2023-2024 opened for encoding on 12 August 2023, and there are still 8,500 schools that have not yet encoded their Quick Count data in the Learner Information System (LIS) as of 24 August 2023 (09:00 AM) generation. Specifically, this accounts for 4,419 public schools, 3,977 private schools, and 104 State/Local Universities and Colleges (SUCs/LUCs) that until now did not yet encode their Quick Count data.

Considering that classes will start on 29 August 2023, all Regional Directors are instructed to ensure and expedite that all schools under their respective jurisdiction

encode their data in the system so that the Department will have a clear picture of the enrollment for School Year 2023-2024.

Likewise, the Regional Offices and Schools Division Offices shall jointly monitor the participation of all schools and provide necessary technical assistance to schools that encounter difficulties in encoding Quick Count data.
