MONITORING OF THE ADMINISTRATION OF THE NATIONAL LEARNING CAMP ASSESSMENT (POST-TEST) FOR INCOMING GRADES 8 AND 9 LEARNERS FOR SY 2023-2024

To Schools Division Superintendents Regional Functional Division Chiefs

- Pursuant to DepEd Memorandum No. 230, s. 2023, Administration of the National Learning Camp Assessment (Post-Test) for Incoming Grades 8 and Grade 9 learners for SY 2023-2024, the Bureau of Education Assessment-Education Assessment Division (BEA-EAD) in coordination with the Information and Communications Technology Service (ICTS), the Regional Office (RO), Schools Division Offices (SDOs) and Schools will administer NLCA post-test to all incoming Grades 8 and 9 learners of SY 2023-2024 from August 31, 2023 to September 22, 2023.
- 2. Anent to this, this Office through the Quality Assurance Division (QAD) will conduct monitoring of the administration of the National Learning Camp Assessment (Post-test) for SY 2023-2024.
- 3. The objective of this monitoring is to ensure that the online computer-based test administration (Post-test) is implemented based on the standards/requirements and determine issues and concerns for the provision of technical assistance.
- 4. The same Regional Monitoring Officials during the conduct of Pre-test last June 21 to July 14, 2023, will monitor the same schools they have monitored during the conduct of Post-test.
- 5. The Monitoring Officials and schools are expected to comply with **R.A. 6713**, the **Code of Conduct and Ethical Standards for Public Officials and Employees**, especially Section 7d. "Public Officials and employees shall not solicit or accept, directly or indirectly, any gift, gratuity, favor, entertainment, loan, or anything of monetary value from any person in the course of their official duties or in connection with any operation being regulated by, or any transaction which may be affected by the functions of their office." And, Section 4 of Article VIII under Code of Ethics For Professional Teachers states that "A

- teacher shall not accept favours or gifts from learners, their parents or others in their behalf in exchange for requested concessions, especially if undeserved".
