RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO LOUIE AND CHIT RESTAURANT AND EVENT CENTER FOR THE PROCUREMENT OF CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS FOR THE TRAINING WORKSHOP ON THE PAYROLL PROCESSES, PROCEDURES, AND FOR THE DOWNLOADING OF PAYROLLS TO THE SCHOOLS DIVISION OFFICES (SDOs)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS** for the **TRAINING WORKSHOP ON THE PAYROLL PROCESSES, PROCEDURES, AND FOR THE DOWNLOADING OF PAYROLLS TO THE SCHOOLS DIVISION OFFICES (SDOs)** on **SEPTEMBER 19-20, 2023 AND SEPTEMBER 26-27, 2023;**

WHEREAS, the Approved Budget for the Contract (ABC) is **TWO HUNDRED FIFTY-SEVEN THOUSAND FOUR HUNDRED PESOS (Php257,400.00);**

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on September 8, 2023 to September 13, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) Louie and Chit Restaurant and Event Center; (2) Munch Box Food Stall; and (3) Jun & Cristy Catering Services;

WHEREAS, one (1) Supplier submitted its proposal; **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** in the amount of **TWO HUNDRED TWENTY-EIGHT THOUSAND EIGHT HUNDRED PESOS (Php228,800.00)**. Thus, **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** in






