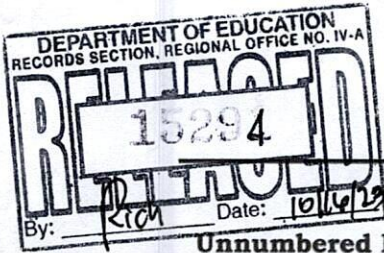

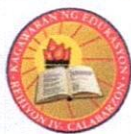
**PARTICIPATION IN THE FINALIZATION OF TEXTBOOK
