SEVILLA RESORT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE REFINEMENT AND VALIDATION OF THE DEVELOPED ALS LEARNING RESOURCE EXEMPLARS OF LEARNING STRANDS 1, 2 AND 3 FOR BASIC LITERACY, ELEMENTARY AND SECONDARY LEVELS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **REFINEMENT AND VALIDATION OF THE DEVELOPED ALS LEARNING RESOURCE EXEMPLARS OF LEARNING STRANDS 1, 2 AND 3 FOR BASIC LITERACY, ELEMENTARY AND SECONDARY LEVELS** on **NOVEMBER 13-17, 2023;**

WHEREAS, the Approved Budget for the Contract (ABC) is **EIGHT HUNDRED FIFTY THOUSAND PESOS (Php850,000.00);**

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting starting on October 4, 2023 to October 9, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) M.I. SEVILLA RESORT; (2) QUEEN MARGARETTE HOTEL, INC.; and (3) CENTRAL PLAZA HOTEL;

WHEREAS, three (3) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
