BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO TAGAYTAY CITY RESORT HOTEL INC (ESTANCIA RESORT HOTEL) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE EDUCATION BOOTCAMP SERIES

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **EDUCATION BOOTCAMP SERIES** on **NOVEMBER 8-10, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **FOUR HUNDRED FORTY-FOUR THOUSAND PESOS (Php444,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on September 28, 2023 to October 3, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) TAGAYTAY AUTO MART, INC. (TAGAYTAY COUNTRY HOTEL); (2) HOTEL KIMBERLY TAGAYTAY; and (3) HOTEL CASIANA TAGAYTAY;

WHEREAS, four (4) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:

WHEREAS, after review and deliberation on the proposal, **TAGAYTAY CITY RESORT HOTEL INC (ESTANCIA RESORT HOTEL)** complied with the requirements and is hereby declared as the Lowest Calculated and Responsive Bid (LCRB);

NOW, THEREFORE, the BAC hereby **RESOLVES**, as it hereby **RESOLVED**:

1. To **DECLARE SUNNY GLADES PROPERTIES CORPORATION (TAGAYTAY HAVEN HOTEL)** as ineligible bidder for failure to comply with the required specifications;
2. To **DECLARE HOTEL DOMINIQUE INC.** as ineligible bidder for failure to comply with the required specifications;
3. To **RECOMMEND** to the Head of Procuring Entity the award of contract to **TAGAYTAY CITY RESORT HOTEL INC (ESTANCIA RESORT HOTEL)** in the amount of **FOUR HUNDRED FORTY-TWO THOUSAND TWO PESOS (Php442,002.00)**.
