

SUBJECT: POSSIBLE REASONS FOR THE LOW TURNOUT OF
ENROLLMENT FOR SCHOOL YEAR 2023-2024 AS
COMPARED TO SCHOOL YEAR 2022-2023

DATE: 25 November 2023

As of 25 November 2023, we have a total enrollment of **27,396,676** million learners for all sectors (public, private, and SLUCs offering basic education). This includes those in the Alternative Learning System (ALS), and pending data for SY 2023-2024.

Although the Learner Information System (LIS) Beginning of School Year (BOSY) 2023-2024 encoding was extended from the original 31 October 2023 deadline, the enrollment figures remain low as compared to the **28,484,730** learners from the reported official enrollment for School Year 2022-2023. As such, there is a negative variance of **1,038,054** learners.

Majority of the decline are from the public schools which accounts for a total of **917,016** learners. For the public Junior High School alone, the negative variance is 683,833 learners, while the decrease in Elementary and Senior High School are 83,167 and 150,016, respectively.
