RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE REGIONAL OFFICE-SCHOOLS DIVISION OFFICE QUARTERLY REGIONAL LEGAL EXECUTIVE COORDINATION MEETING (ReLEXECOM)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **REGIONAL OFFICE-SCHOOLS DIVISION OFFICE QUARTERLY REGIONAL LEGAL EXECUTIVE COORDINATION MEETING (ReLEXECOM)** on **DECEMBER 5-6, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY-EIGHT THOUSAND PESOS (Php128,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on November 16, 2023 to November 21, 2023 at 9:00 a.m.;


WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) SUNRISE RIDGE CORPORATION (SOLESTE SUITES); (2) CAMELOT HOTEL; and (3) BSA TWIN TOWER HOTEL;

WHEREAS, one (1) Supplier submitted its proposal: **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount of **ONE HUNDRED TWENTY-ONE THOUSAND SIX HUNDRED PESOS (Php121,600.00)**. Thus, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);




