WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **TARGET SETTING FOR FY 2024 OPCR AND IPCR FOR ADMINISTRATIVE SERVICES DIVISION PERSONNEL** on **DECEMBER 6-8, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED THIRTY-EIGHT THOUSAND PESOS (Php138,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on November 15, 2023 to November 20, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) SUNRISE RIDGE CORPORATION (SOLESTE SUITES); (2) RED HOTEL INC.; and (3) CAMELOT HOTEL;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
