## **BAC RESOLUTION**

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE 2023 ANNUAL PHYSICAL AND LABORATORY EXAMINATION WITH VACCINATION OF DEPED REGIONAL EMPLOYEES

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the 2023 ANNUAL PHYSICAL AND LABORATORY EXAMINATION WITH VACCINATION OF DEPED REGIONAL EMPLOYEES on NOVEMBER 10 & 17 and 24, 2023;

WHEREAS, the Approved Budget for the Contract (ABC) is **SIXTY-ONE THOUSAND** FIVE HUNDRED PESOS (Php61,500.00);

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on October 19, 2023 to October 25, 2023 at 9:00 a.m.;

**WHEREAS,** RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) GOD'S TREASURE ENTERPRISES; (2) FOCAL MANAGING LOOP INC.; and (3) MEYERS FOODS AND SERVICES INC.;

WHEREAS, one (1) Supplier submitted its proposal: GOD'S TREASURE ENTERPRISES in the amount of SIXTY-ONE THOUSAND NINETY PESOS (Php61,090.00). Thus, GOD'S TREASURE ENTERPRISES is declared as the lone bidder;

**WHEREAS,** after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD'S TREASURE ENTERPRISES** in the amount **SIXTY-ONE THOUSAND NINETY PESOS (Php61,090.00)**.
