RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO TAGAYTAY COUNTRY HOTEL FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE PROGRAM IMPLEMENTATION REVIEW AND TECHNICAL ASSISSTANCE ON THE DEVELOPMENT OF DIVISION STRATEGIC HRD PLAN FOR FY 2024

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the PROGRAM IMPLEMENTATION REVIEW AND TECHNICAL ASSISSTANCE ON THE DEVELOPMENT OF DIVISION STRATEGIC HRD PLAN FOR FY 2024 on NOVEMBER 28-30, 2023;

WHEREAS, the Approved Budget for the Contract (ABC) is FOUR HUNDRED EIGHTY

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H"

WHEREAS, the Request for Quotation (RFQ) was posted in the Phillippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on November 8, 2023 to November 13, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) CALIV RESORT AND DEVELOPMENT CORP. (VILLA EXCELLANCE BEACH AND WAVE POOL RESORT); (2) TAGAYTAY COUNTRY HOTEL; and (3) THE BAYLEAF HOTEL;
