**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND

WHEREAS, out of nine (9) bids submitted, eight (8) suppliers passed the preliminary and detailed evaluation of bids conducted by the Bids and Awards Committee (BAC), subject to post qualification;

WHEREAS, during bid evaluation, the BAC found that **THE BOOKMARK INC.** was ineligible because its Single Largest Completed Contract (SLCC) was insufficient. The SLCC must be at least fifty percent (50%) of the ABC. Thus, **THE BOOKMARK INC.** is declared as non-responsive and/or non-compliant;

WHEREAS, the BAC resolved to declare, as follows that:

- a. **LAMPARA PUBLISHING HOUSE, INC.**, as the bidder with the Single Calculated Bid (SCB) for Lot I with a bid price of **TWENTY-FIVE MILLION FOUR HUNDRED NINETY-FIVE THOUSAND FIVE HUNDRED NINETY PESOS (Php25,495,590.00)**;
- b. **ADARNA HOUSE INC.**, as the bidder with the Single Calculated Bid (SCB) for Lot II with a bid price of **THIRTEEN MILLION ONE HUNDRED TWENTY-SEVEN THOUSAND TWO HUNDRED EIGHTY-THREE PESOS (Php13,127,283.00)**;
- c. **OMF LITERATURE INC.**, as the bidder with the Single Calculated Bid (SCB) for Lot III with a bid price of **FIVE MILLION SIX HUNDRED SEVENTY-FOUR THOUSAND ONE HUNDRED THIRTY-FIVE PESOS (Php5,674,135.00)**;
- d. **ST. BERNADETTE PUBLISHING HOUSE CORP.**, as the bidder with the Single Calculated Bid (SCB) for Lot V with a bid price of **TWO MILLION THREE HUNDRED ONE THOUSAND SEVEN HUNDRED NINETY PESOS (Php2,301,790.00)**;
- e. **ST. MARY'S PUBLISHING CORP.**, as the bidder with the Single Calculated Bid (SCB) for Lot VI with a bid price of **ONE MILLION NINE HUNDRED FORTY-ONE THOUSAND EIGHT HUNDRED FORTY PESOS (Php1,941,840.00)**;
- f. **JOHNNY AND HANSEL PUBLICATION**, as the bidder with the Single Calculated Bid (SCB) for Lot VII with a bid price of **ONE MILLION THREE HUNDRED EIGHTY-FOUR THOUSAND ONE HUNDRED PESOS (Php1,384,100.00)**;
- g. **HRRP ENTERPRISE**, as the bidder with the Single Calculated Bid (SCB) for Lot VIII with a bid price of **SEVEN HUNDRED FIFTY-SIX THOUSAND SIX HUNDRED PESOS (Php756,600.00)**;
- h. **VICARISH PUBLICATION AND TRADING INC.**, as the bidder with the Single Calculated Bid (SCB) for Lot X with a bid price of **FOUR HUNDRED SIXTEEN THOUSAND ONE HUNDRED THIRTY PESOS (Php416,130.00)**;

WHEREAS, the result of the post-qualification showed that all the eight (8) suppliers are responsive with the procurement requirements for Lot I, Lot II, Lot III, Lot V, Lot VI, Lot VII, Lot VIII and Lot X, per attached post-qualification report;

NOW, THEREFORE, the BAC hereby RESOLVES as it hereby RESOLVED:


1. To **DECLARE THE BOOKMARK INC.** as ineligible bidder for failure to comply with the required documents;
2. **To DECLARE LAMPARA PUBLISHING HOUSE, INC.** as the Single Calculated and Responsive Bidder for Lot I, in the amount of **TWENTY-FIVE MILLION FOUR HUNDRED NINETY-FIVE THOUSAND FIVE HUNDRED NINETY PESOS (Php 25,495,590.00);**
3. **To DECLARE ADARNA HOUSE INC.** as the Single Calculated and Responsive Bidder for Lot II, in the amount of **THIRTEEN MILLION ONE HUNDRED TWENTY-SEVEN THOUSAND TWO HUNDRED EIGHTY-THREE PESOS (Php13,127,283.00);**
4. **To DECLARE OMF LITERATURE INC.** as the Single Calculated and Responsive Bidder for Lot III, in the amount of **FIVE MILLION SIX HUNDRED SEVENTY-FOUR THOUSAND ONE HUNDRED THIRTY-FIVE PESOS (Php5,674,135.00);**
5. **To DECLARE ST. BERNADETTE PUBLISHING HOUSE CORP.** as the Single Calculated and Responsive Bidder for Lot V, in the amount of **TWO MILLION THREE HUNDRED ONE THOUSAND SEVEN HUNDRED NINETY PESOS (Php2,301,790.00);**
6. **To DECLARE ST. MARY'S PUBLISHING CORP.** as the Single Calculated and Responsive Bidder for Lot VI, in the amount of **ONE MILLION NINE HUNDRED FORTY-ONE THOUSAND EIGHT HUNDRED FORTY PESOS (Php1,941,840.00);**
7. **To DECLARE JOHNNY AND HANSEL PUBLICATION** as the Single Calculated and Responsive Bidder for Lot VII, in the amount of **ONE MILLION THREE HUNDRED EIGHTY-FOUR THOUSAND ONE HUNDRED PESOS (Php1,384,100.00);**
8. **To DECLARE HRRP ENTERPRISE** as the Single Calculated and Responsive Bidder for Lot VIII, in the amount of **SEVEN HUNDRED FIFTY-SIX THOUSAND SIX HUNDRED PESOS (Php756,600.00);**
9. **To DECLARE VICARISH PUBLICATION AND TRADING INC.** as the Single Calculated and Responsive Bidder for Lot X, in the amount of **FOUR HUNDRED SIXTEEN THOUSAND ONE HUNDRED THIRTY PESOS (Php416,130.00);**
10. **To RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the **award of contracts to LAMPARA PUBLISHING HOUSE, INC., ADARNA HOUSE INC., OMF LITERATURE INC., ST. BERNADETTE PUBLISHING HOUSE CORPORATION, ST. MARY'S PUBLISHING CORPORATION, JOHNNY AND HANSEL PUBLICATIONS, HRRP ENTERPRISE and VICARISH PUBLICATIONS AND TRADING INC.** for Lot I, Lot II, Lot III, Lot V, Lot VI, Lot VII, Lot VIII and Lot X, respectively, for the Supply and Door to Door Delivery of Supplementary Learning Resources (SLRs) for Library Hubs with reference number ROIVA-23-06.
