WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the ANNUAL 18-DAY CAMPAIGN TO END VIOLENCE AGAINST WOMEN AND CHILDREN (VAWC) - CULMINATING ACTIVITY on DECEMBER 18-19, 2023;

WHEREAS, the Approved Budget for the Contract (ABC) is **TWO HUNDRED NINETY-TWO THOUSAND PESOS (Php292,000.00)**;

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on December 6, 2023 to December 11, 2023 at 9:00 a.m.;

**WHEREAS,** RFQs were sent to at least three (3) prospective suppliers as follows: (1) GOD'S TREASURE ENTERPRISES; (2) FOCAL MANAGING LOOP INC.; and (3) MEYERS FOODS AND SERVICES INC.;

WHEREAS, one (1) Supplier submitted its proposal: GOD'S TREASURE ENTERPRISES in the amount of TWO HUNDRED EIGHTY-SEVEN THOUSAND TWO HUNDRED PESOS (Php287,200.00). Thus, GOD'S TREASURE ENTERPRISES is declared as the lone bidder:

**WHEREAS,** after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);
