BAC RESOLUTION

RECOMMENDING THE AWARD FOR THE REPEAT ORDER TO GOLDILUCKS STEEL MANUFACTURING CORP. FOR THE PROCUREMENT OF SUPPLY AND DOOR TO DOOR DELIVERY OF SCHOOL FURNITURE FOR ELEMENTARY, JUNIOR AND SENIOR HIGH SCHOOLS UNDER THE BASIC EDUCATIONAL FACILITIES FUND (BEFF) SCHOOL FURNITURE PROGRAM CY 2022 (ROIVA-23-04)

WHEREAS, on September 27, 2023, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the **SUPPLY AND DOOR TO DOOR DELIVERY OF SCHOOL FURNITURE FOR ELEMENTARY, JUNIOR AND SENIOR HIGH SCHOOLS UNDER THE BASIC EDUCATIONAL FACILITIES FUND (BEFF) SCHOOL FURNITURE PROGRAM CY 2022 (ROIVA-23-04)** in the PhilGEPS website, office website, and in conspicuous bulletin board of the Office;

WHEREAS, submission and opening of bids was held on October 18, 2023, 10:00am at Bulwagan ng Karangalan, DepEd Region IV-A CALABARZON;

WHEREAS, the contract was awarded to **GOLDILUCKS STEEL MANUFACTURING CORP.**;

WHEREAS, the end-user requested for the repeat order for the above activity;

WHEREAS, the Purchase Request was approved by the Head of the Procuring Entity;

WHEREAS, the BAC received the approved Purchase Request (PR), hence, the committee convened to check the PR and other supporting documents for the repeat order;

WHEREAS, in reference to the provision of the 2016 Revised Implementing Rules and Regulations (R-IRR) of the Republic Act (RA) No. 9184, otherwise known as the Government Procurement Reform Act, the BAC agreed to use Alternative Method of Procurement, as stated below:

Section 51. Repeat Order, when provided for in the APP, is a method of procurement of Goods from the previous winning bidder, whenever there is a need to replenish goods procured under a contract previously awarded through Competitive Bidding. Repeat orders shall likewise be subject to the following conditions:

- Unit prices of the repeat order must be the same as or lower than those in the original contract: Provided, that such prices are still the most advantageous to the GOP after price verification;*
- The repeat order will not result in splitting of contracts, requisitions, or purchase orders, as provided for in Section 54.1 of the IRR;*

- c. *Except in cases duly approved by the GPPB, the repeat order shall be availed of only within six (6) months from the date of the Notice to Proceed arising from the original contract: Provided, that there has been a partial delivery, inspection and acceptance of the goods within the same 6-month period; and*
- d. *Repeat orders shall not exceed twenty-five (25%) of the quantity of each item in the original contract. In order not to exceed the 25% threshold, the goods under the original contract must be: (i) Quantifiable; (ii) Divisible; and (iii) Consisting of at least four (4) units per item.*

WHEREAS, after thorough review of R.A. 9184 and its revised IRR, majority of the BAC agreed that the procurement of Supply and Door to Door Delivery of School Furniture for Elementary, Junior and Senior High Schools Under the Basic Educational Facilities Fund (BEFF) School Furniture Program CY 2022 is through Repeat Order;

WHEREAS, upon careful examination, validation and verification of the prevailing market price of the goods to be reordered and justification for re-ordering from the end-user has been found responsive due to the following:

- a. The original contract have been found procured through competitive bidding;
- b. Unit prices are the same as the original contract and still the most advantageous to the government after price verification;
- c. The repeat order will not result in the splitting of contracts, requisitions of purchase orders, as provided for in Section 54.1 of the 2016 R-IRR; and
- d. The repeat order shall be availed of only within six (6) months from the date of the Notice to Proceed arising from the original contract.

WHEREAS, the items specified on the table below are requested by the end-user and hereby awarded to **GOLDILUCKS STEEL MANUFACTURING CORP.**;
