## BAC RESOLUTION

DECLARING THE DISQUALIFICATION OF THE FIRST AND SECOND LOWEST BIDDERS AND RECOMMENDING TO AWARD THE CONTRACT TO THE THIRD LOWEST CALCULATED BID FOR THE PROCUREMENT OF SUPPLY AND DOOR TO DOOR DELIVERY OF SCHOOL FURNITURE FOR ELEMENTARY, JUNIOR AND SENIOR HIGH SCHOOLS UNDER THE BASIC EDUCATIONAL FACILITIES FUND (BEFF) SCHOOL FURNITURE PROGRAM CY 2023 (ROIVA-23-05)

WHEREAS, on October 6, 2023, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the SUPPLY AND DOOR TO DOOR DELIVERY OF SCHOOL FURNITURE FOR ELEMENTARY, JUNIOR AND SENIOR HIGH SCHOOLS UNDER THE BASIC EDUCATIONAL FACILITIES FUND (BEFF) SCHOOL FURNITURE PROGRAM CY 2023 (ROIVA-23-05) in the PhilGEPS website, office website, and in conspicuous bulletin board of the Office;

WHEREAS, the Approved Budget for the Contract (ABC) is **EIGHTY-ONE MILLION ONE HUNDRED SIXTY THOUSAND SIX HUNDRED PESOS (Php 81,160,600.00)**;

**WHEREAS,** in response to the Invitation to Bid for the above mentioned procurement, the BAC received five (5) sealed bids, offering the following financial bids, as read:

**WHEREAS,** on November 7, 2023, the Bids and Awards Committee (BAC) conducted a bid evaluation of the documents submitted. The results of the evaluation and deliberation are as follows:

			The BAC found the following:  1. The attached technical specifications for learners table and learners chair are for E-Bamboo instead of HDPE; and

2. The attached after sales warranty is one (1) year instead of two (2) years. Notice of Disqualification was issued on November 7, 2023 and no motion for reconsideration was filed. ASIAPRIME COMMODITIES CORP. Submitted as 2nd Lowest & WILLIEMART (JV) Calculated Bid. The BAC found that there is inconsistency in the issued Warranty Certificate. Notice of Disqualification was issued on November 7, 2023. On November 9, 2023 a Motion for Reconsideration was filed, which was granted and the notice of disqualification canceled. On November 28, 2023, postqualification was conducted. During the post-qualification, the BAC and TWG found the following: 1. The Mayor's Permit of Willie Mart is still subject for inspection; 2. The Office address given by Willie Mart is a paint store and not an office where they keep complete records of their transactions: 3. The alleged manufacturing plant shown representatives of Willie Mart at 137 Ivory St., ITC Bagbaguin, Compound, Valenzuela City, registered under the business name of Dunamis Metal Coating Corp.; and 4. The DOST certificate submitted, though under level 5, shows that the stability test for the learners' chair was not performed. **GOLDILUCKS** STEEL Submitted as 3rd Lowest MANUFACTURING CORP. Calculated Bid and subjected for post-qualification on December 18, 2023.

**WHEREAS,** the BAC opted to adopt the post-qualification report dated October 27, 2023 for GOLDILUCKS STEEL MANUFACTURING CORP.

**WHEREAS,** upon careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted by **GOLDILUCKS STEEL MANUFACTURING CORP.**, being the 3rd Lowest Calculated Bidder has been found to be responsive;

NOW, THEREFORE, the BAC hereby RESOLVES as it hereby RESOLVED:

- 1. To DECLARE HAUWEI BUILDERS & DEVELOPMENT CORP. and ASIAPRIME COMMODITIES CORP. & WILLIEMART (JV) as ineligible bidders for failure to comply with the requirements of this Office;
- 2. To DECLARE GOLDILUCKS STEEL MANUFACTURING CORP. as eligible bidder and having the Lowest Calculated and Responsive Bid in the amount of FIFTY MILLION THREE HUNDRED NINETY THOUSAND EIGHT HUNDRED PESOS (Php50,390,800.00); and
- 3. **To RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the **award of contract to GOLDILUCKS STEEL MANUFACTURING CORP.** for the Supply and Door to Door Delivery of School Furniture for Elementary, Junior and Senior High Schools Under the Basic Educational Facilities Fund (BEFF) School Furniture Program CY 2023 with reference number ROIVA-23-05.
