RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO GDC AND ASSOCIATES DEVELOPMENT CORPORATION FOR THE PROCUREMENT OF MATERIALS FOR THE PROVISION OF POWER SUPPLY FOR THE 4 SETS OF CEILING MOUNTED CASSETTE TYPE AIR CONDITIONING UNITS (ACUs) AT NEAP-RELC

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **MATERIALS FOR THE PROVISION OF POWER SUPPLY FOR THE 4 SETS OF CEILING MOUNTED CASSETTE TYPE AIR CONDITIONING UNITS (ACUs) AT NEAP-RELC**;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY-SEVEN THOUSAND FOUR HUNDRED TWENTY-EIGHT PESOS AND 30/100 (Php127,428.30)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on January 8, 2024 to January 15, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Naujan Aircon Enterprises; (2) L Taneo Mechanical Services; and (3) La Breeze and Ref and Aircon Parts and Services;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
