WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement
of RELC-NEAP IV-A CALABARZON CONSUMABLES FOR 2024 - 1ST QUARTER;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED THIRTY-
THREE THOUSAND SEVEN HUNDRED EIGHTY-TWO PESOS AND 50/100
(Php133,872.50);

WHEREAS, Section 52.1 (b) of the 2016 Revised Implementing Rules and
Regulations (R-IRR) of Republic Act (RA) No. 9184, otherwise known as the
“Government Procurement Reform Act of 2003”, allows an agency to resort to
Shopping as a method of procurement of goods whereby the procuring entity simply
requests the submission of price quotations for readily available off-the-shelf goods
or ordinary/regular equipment to be procured directly from suppliers of known
qualification wherein the procurement of ordinary or regular office supplies and
equipment not available in the Procurement Service does not exceed the threshold
amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine
Government Electronic Procurement System (PhilGEPS), office website and
conspicuous bulletin board in the premises of this Office starting on January 23,
2024 to January 29, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to five (5) prospective suppliers as follows: (1) JTPP Office
and School Supplies Trading; (2) Silent Worker Marketing; (3) Kyrie Trading; (4) RDY3
General Merchandise; and (5) K&L Core Consumer Goods Trading;

WHEREAS, three (3) suppliers submitted their respective proposals before the
deadline for the submission of bids, offering the following financial bids, as read:


