**BAC RESOLUTION**

**RECOMMENDATION TO APPROVE THE OFFER OF NATIONAL PRINTING OFFICE (NPO) FOR THE PRINTING AND DELIVERY OF QUARTER 4 GRADES 5, 6 AND 8 SELF-LEARNING MODULES (SLMs) FOR FISCAL YEAR (FY) 2024**

**WHEREAS**, DepEd Region IV-A CALABARZON intends to procure services for the printing and delivery of Quarter 4 Grades 5, 6 and 8 Self-Learning Modules (SLMs) for FY 2024.

**WHEREAS**, this Office received an indicative allocation in the amount of **Three Hundred Sixty-Two Million Nine Hundred Seventy-Nine Thousand Five Hundred Twenty-Five Pesos (Php362,979,525.00)** for the production and delivery of Self-Learning Modules (SLMs) for FY 2024;

**WHEREAS**, on December 20, 2023, the BAC, BAC Secretariat, TWG and representative from the End-User conducted a pre-procurement conference to discuss the said allotment for the printing and delivery of SLMs for FY 2024;

**WHEREAS**, taking into consideration the market study showing a higher unit cost of the private printing company as well as the high volume of SLMs to be produced, the BAC proposed the procurement of Quarter 4 Grades 5, 6 and 8 SLMs for FY 2024 through negotiated procurement under Agency-to-Agency;

**WHEREAS**, the BAC proposed the procurement of Quarter 4 Grades 5, 6 and 8 SLMs for FY 2024 through negotiated procurement under Agency-to-Agency considering the high volume of SLMs to be produced;

**WHEREAS**, on December 21, 2023 the BAC thru its Secretariat, initiated the procurement activity by sending quotation to APO Production Unit, Inc. (APO) and National Printing Office (NPO);

**WHEREAS**, APO and NPO submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:

**WHEREAS**, in view of the recently concluded project by APO where there was delay in the delivery and some problems incurred relative to the packaging of the SLMs, the BAC agreed to award the project to NPO;

**WHEREAS**, this Office received the approved allocation in the amount of **THREE HUNDRED SIXTY-SIX MILLION SEVEN HUNDRED FOURTY-EIGHT THOUSAND PESOS (Php366,748,000.00)**;

**WHEREAS**, on January 19, 2024, the BAC decided to send another RFQ to National Printing Office (NPO) due to the increase Approved Budget for the Contract (ABC);

**WHEREAS**, in response National Printing Office (NPO) submitted its proposal in the amount of Php0.65 per page;

**WHEREAS**, after evaluation of the quotation with attached certificate, it was determined that the offer of NPO provides the most advantageous term to this Office;

**WHEREAS**, the BAC approves the offer of NPO;


**NOW, THEREFORE**, the BAC hereby **RESOLVES**, as it hereby **RESOLVED**:






